ORDER

The Principal, Malabar Medical College Hospital and Research Centre, Kozhikode vide paper read (1) above, applied for provisional affiliation for starting 9 Medical PG courses mentioned in the table below for the academic year 2020-21.

2.The University, vide paper read (2) above, after conducting inspection and the scrutiny of the inspection report, granted consent of affiliations to Malabar Medical College Hospital and Research Centre,Kozhikode for starting above mentioned 9 Medical PG courses with 2 seats each for the academic year 2020-21.

3.As per paper read (3) above, the Medical Council of India has granted Letters of Permission for starting 9 Medical PG courses with 2 seats each mentioned in the table at Malabar Medical College Hospital and Research Centre,Kozhikode for the academic year 2020-21.

4. Due to the out break of Covid 19, the mandatory inspection to be conducted before granting provisional affiliation for starting/enhancement of seats and other normal procedures to be followed while granting provisional affiliation could not be completed. The allotment process to the Medical PG courses for the academic year 2020-21 has been started from 13/04/2020.

5.Considering the urgency the Hon'ble Vice Chancellor, vide paper read (4) above, has accorded sanction to grant conditional provisional affiliation for starting 9 Medical PG courses at Malabar Medical College Hospital and Research Centre,Kozhikode for the academic year 2020-21 as mentioned in the table below and subject to following conditions and ratification by the Governing Council.

- i. The conditional affiliation granted for starting new/enhanced seats in Medical PG courses is strictly for the academic year 2020-21 admissions only.
- ii.The university would be free to conduct surprise inspections in the institution to assess the facilities as and when the same is possible and the final decision on the application for affiliation would be taken based on the inspection reports.



iii.If the college fails maintain the necessary facilities in terms of the norms fixed by the university and other statutory institutions appropriate actions would be initiated against the institutions.

iv.If the surprise inspection conducted by the University reveals any deficiency in the institution, the conditional affiliation presently granted would be cancelled, and the students already admitted to the course during the year 2020-21 may be shifted to other colleges.

The Principal, Malabar Medical College Hospital and Research Centre, Kozhikode vide paper read (5) above, have submitted an undertaking accepting the above conditions stipulated by the University for granting conditional provisional affiliation for starting 9 Medical PG courses for the academic year 2020-21.

6. The college has to comply the following general conditions.

1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be canceled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
3. Affiliation granted is strictly provisional and only for the academic year 2020-21. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
4. Admission to the next academic year shall be made only after obtaining prior permission from the University.
5. The College should remit Annual Administration fee of Rs.220500/- (Two lakh twenty Thousand Five Hundred) per course after closure of admission for the academic year 2020-21.
6. The College should collect fees (One time payment at the time of admission) from the students to be remitted to the University as follows: -
