The Principal, Malabar Medical College Hospital & Research Centre, Kozhikkode-MM015, vide paper read (2) above, has submitted application for the continuation of provisional affiliation for the year 2020-21

On verification of the applications, it is found that the college has submitted necessary documents and remitted required fee for continuation of provisional affiliation for the year 2020-21. The inspection commission vide paper read (3) above, has submitted the inspection report after conducting inspection in the college. The Scrutiny Committee, vide paper read (4) above, after verifying the inspection report, has pointed out the deficiency of faculty and the same has been intimated to the college. In response to the deficiency letter the College vide paper read (5) above has submitted compliance report. The Scrutiny Committee, vide paper read (6) above, after verifying the compliance report, recommended to conduct a surprise re-inspection at the College. The inspection commission vide paper read (7) above, has submitted report after conducting a surprise re-inspection. Again the Scrutiny Committee, vide paper read (8) above, after verifying the surprise re-inspection report, has recommended to grant continuation of provisional affiliation to Malabar Medical College, Kozhikkode for the academic year 2020-21. The Governing Council vide paper read as (9) above, has decided to grant continuation of provisional affiliation to Malabar Medical College, Kozhikkode for the academic year 2020-21. The college has obtained letter of permission/recognition from Ministry of Health and Family Welfare for conducting courses mentioned below.

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2020-21. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG/PG course for the academic year 2020-21. The College shall produce the orders regarding the constitution of College Council for the academic year 2020-21 during the time of student data verification
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
