ORDER

1. The University had issued Consent of Affiliation in 2022-23, for starting/enhancement of various medical PG Courses for the academic year 2022-23 to Medical Colleges, in accordance with para 2(5)(ix) of the Amendment of the First Statute on the Matter of Affiliation of the Colleges.

2. Though final inspection was conducted in some of the colleges and Provisional Affiliation was granted after following the due process envisaged in the Amendment of the 1st Statute on the Matter of Affiliation of the Colleges this process could not be completed in the colleges mentioned below before the start of allotment procedure for the Academic year 2022-23, due to the late receipt of Letter of Permission from the National Medical Commission.

4. The 71st Governing Council discussed the matter in detail. Taking into the consideration, the time constraints to complete process of granting Provisional Affiliation before the allotment process, the Governing Council, vide paper read(1) above, decided to grant Conditional Provisional Affiliation to the Courses/Colleges listed above with an intake mentioned against the course and name of colleges.

5. In the Circumstances, sanction is hereby accorded to grant Provisional Affiliation to the Colleges/Courses as per the list above, for the academic year 2022-23 in accordance with 2(5)(ix) Section 16 of the Amendment of the 1st Statute on the Matter of Affiliation of the Colleges, subject to the Condition that the colleges shall comply with all the requirements to conduct the courses for which Provisional Affiliation now granted, after the process completed by the University. If the conditions are not fulfilled by the end of the period fixed, the Provisional Affiliation now granted shall cease automatically. The educational agency/institution shall give an undertaking in stamp Paper worth of **Rs 200/-**, that the loss suffered by the students admitted to the institution, in the event of affiliation being not granted due to non-fulfillment of the conditions, shall be compensated by the educational agency/institution. The Undertaking shall be forwarded to the University so as to reach the same on or before **30th January 2023**, failing which, the conditional Provisional Affiliation now granted shall become null and void.

6. In addition to the above, colleges shall also satisfy the conditions detailed below:-

a) Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.

(b) In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging,

appropriate action including withdrawal of affiliation of the College will be initiated.

(c) Affiliation granted is strictly provisional and only for the academic year 2022-23. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

(d) Admission to the next academic year shall be done only after obtaining prior permission from the University.

(e) The College should remit Annual Administration fee of **Rs.2,20,500/- (Two lakh twenty thousand five hundred only)** per course after closure of admission for the academic year 2022-23.

(f) The College should collect fees (one time payment at the time of admission) from the students to be remitted to the University as follows:
