



## Memorandum of Understanding Between

INSTITUTIONS UNDER SREE ANJANEYA MEDICAL TRUST- SREE ANJANEYA INSTITUTE OF DENTAL SCIENCES, MALABAR MEDICAL COLLEGE HOSPITAL & RESEARCH CENTRE, SREE ANJANEYA COLLEGE OF NURSING AND SREE ANJANEYA COLLEGE OF PARAMEDICAL SCIENCES AND

## RAK MEDICAL & HEALTH SCIENCES UNIVERSITY- UNITED ARAB EMIRATES

In order to promote mutual cooperation and extend mutual understanding, Institutions under Sree Anjaneya Medical trust - viz Sree Anjaneya Institute of Dental Sciences, Malabar Medical College Hospital & Research Centre, Sree Anjaneya College of Nursing and Sree Anjaneya College of Paramedical Sciences and RAK Medical & Health Sciences University, Ras Al Khaimah, UAE agree to enter into a mutual Memorandum of Understanding (MOU) on the following articles.

- I- Institutions under Sree Anjaneya Medical trust viz Sree Anjaneya Institute of Dental Sciences, Malabar Medical College Hospital & Research Centre, Sree Anjaneya college of Nursing and Sree Anjaneya College of Paramedical Sciences and RAK Medical & Health Sciences University agree to cooperate on the following items, within the extent of each country's regulations and facilities.
- 1) Promotion of joint research works including exchange of faculty and research members.
- 2) Development of student exchange programs including short term clinical training in accordance with the legislation of both countries upon approval from Dental council of India (DCI), National Medical Commission, Indian Nursing Council respectively as the case may be and Kerala University of Health Sciences (KUHS) and Commission for Academic Accreditation (CAA) under the Ministry of Higher Education & Scientific Research (MOHE & SR).
- 3) Exchange of academic research data and technical materials.
- 4) Cooperation in publication and cultural activities.
- 5) Organization of joint academic and scientific activities such as conferences, seminars, symposiums and continuing medical and health science education programs.
- II- Exchanges activities related with the joint research works shall be planned separately by taking into consideration each university facilities and conditions; the rules and procedures of the exchange program shall be determined in a separate protocol between the parties. (Our centre Stem cell and Regenerative medicine can be utilised for joint research activities in the field of regenerative medicine)
- III- The academic exchanges described above shall be limited to legislation in force in each country and to their respective budgetary resources.
- IV- This protocol shall not cause any binding financial obligation for either party.
- V- Signature of this MOU shall not cause any obligation for either party to enter into any specific agreement relating to cooperation between two universities.

VI- In case that research results impacting upon matters of intellectual property rights are expected to arise in the course of collaborative projects within the scope of this protocol, the parties shall enter into an additional protocol governing the conditions regarding the treatment of intellectual property rights so arising, prior to the start of the collaborative project in question.

VII- The execution of this MOU shall be subject to the laws in force in each Parties country. The parties are responsible for obtaining the required in-house or other approvals in accordance with the legislation.

VIII- This MOU shall be in effect for five years following the date of signature. This MOU may be complemented or amended by the written and common consent of authorized representatives of both universities and additional protocols to this protocol. The Addenda or amendments will not be valid unless it is written and signed. The MOU may be extended for another five years by written and signed consent of the parties.

IX- Each university shall reserve the right to terminate the MOU by issuing a written notice six months in advance to the other party. In that case, on-going projects shall continue until they are completed.

This MOU shall become effective after signing by the authorized representatives of both universities.
